Pikes Peak BOCES Special Education Administrative Unit


Pikes Peak BOCES's Special Education Administrative Unit (SPED AU) consists of 9 school districts in Colorado: Big Sandy #100J, Calhan #RJ1, Edison #54JT, Elbert #200, Ellicott #22, Fremont #RE2, Hanover #28, Miami-Yoder #60JT, and Peyton #23JT. Each district has some level of local control in regards to addressing the impact of COVID-19 on in-person learning, including plans for the safe return to in-person instruction and continuity of services, layered prevention strategies, and a system of phased prevention. Therefore, while a Pikes Peak BOCES staff is serving students within one of those districts, that staff member shall follow the requirements of that district regarding safe in-person learning plans. Pikes Peak BOCES will do its best to provide the technological support needed to allow staff members to provide services within the remote and in-person instructional setting of the district(s) that they work in.

This plan was implemented at the onset of the COVID-19 pandemic in March 2020 and continues to the present day.
